

Numerica Credit Union \$tarting Off Right Scholarship

The terms 'you' and 'your' refer to the person applying for the scholarship. The terms 'we', 'us', 'our', and 'Numerica' refer to Numerica Credit Union.

Important Dates

- Applications open: February 1, 2025
- Application closes: February 28, 2025 at midnight
- Judging: March 3 28, 2025
- Winners will be notified by phone on or before April 1, 2025

Eligibility Requirements

To be eligible for one of 16 \$1,250 Numerica Credit Union \$tarting Off Right Scholarships, you must meet all of the following requirements:

- Be a Numerica member in good standing
- High school senior entering into a trade, vocational, certificate, associate, or bachelor's degree program in the fall of 2025.
- Provide two letters of recommendation from different sources, for example, a teacher, coach, manager, nonprofit, pastor, or school counselor
- Minimum word count of 150 must be met on all narrative application questions
- Provide a copy of an acceptance letter from a regionally or nationally accredited institution of higher education, trade school, or vocational program.
- Provide an attachment showing your FAFSA/SAI Documentation or Explanation for lack of SAI score.
- Must complete financial education "Preparing to Pay for College" quiz and attach a screenshot of the confirmation screen.

Numerica employees are prohibited from applying. However, dependents and immediate family members of Numerica employees are permitted to apply. Relation to a Numerica employee will have no bearing on the decision-making process.

Application

- 1. Application and all requested information submitted by February 28, 2025.
- 2. Answer application questions in full.
 - a. Describe the financial gap you expect to have between your annual cost of education and what you and/or your family can contribute. Please also list any secured grants or additional scholarships already secured.

- c. What are your future career plans and how will they support you in building your community?
- d. How have you been involved in your community recently or what barriers prevent you from being involved in your community?
- 3. Acceptance letter from a regionally or nationally accredited institute of higher education, trade school, or vocational program.
- 4. Two (2) letters of recommendation from different sources, for example, teacher, coach, manager, nonprofit, pastor, or school counselor
- 5. Attachment showing FAFSA/SAI Documentation or Explanation for lack of SAI score.

Selection

- 1. All applications that meet the above requirements will be reviewed by Numerica staff.
- 2. A team of Numerica staff will select the winners.
- 3. There will be 3 winners selected from the Wenatchee region, 3 winners from the Tri-Cities region, 3 winners from the North Idaho region and 7 winners from the Spokane region. An effort will be made to award up-to half of the scholarship funds to students attending either community college, trade or vocational school, and half of the scholarship funds to students attending funds to students attending a 4-year institution.

Payment

- 1. The Scholarship funds will be paid to the institute of higher education that the recipient is attending in the recipient's name.
- 2. Scholarship funds will be paid directly to the school, prior to the start of the school year.
- 3. Scholarship funds must be applied towards tuition, fees, books, supplies, and equipment required for the recipient's classes.
- 4. Any surplus may be paid to the recipient for necessary expenses related to the attendance at the institute of higher education.
- 5. Scholarship will be applied evenly to each academic term the recipient is enrolled in.
- 6. If the recipient withdraws from the institute, any unused portion of the scholarship will be revoked and remitted back to Numerica.
- 7. If the recipient fails to register for any academic term, does not use the scholarship money for educational expenses, or becomes noncompliant with the financial aid policies of the institute of higher education, then any unused portion of the award may be revoked and remitted to Numerica.



Numerica members must reside in a county where Numerica Branches are present

Other important information

- 1. In the event that Numerica believes that the integrity of the scholarship has been irreparably harmed, Numerica reserves the right to cancel or postpone this scholarship for any reason.
- 2. Recipient is responsible for any and all tax liabilities that result from the receipt and use of any scholarship/scholarship received.
- 3. No purchase necessary to enter or win.
- 4. Recipients will be notified by phone or email.
- 5. By submitting an application, you agree that we may contact you using any of the methods of communication that you provide us.
