

## The Numerica DreamUp Giveaway

The promotion begins on October 6, 2025, and ends on December 31, 2025. All entries must be received by December 31, 2025, at 11:59 p.m. PDT to be considered.

Entrants will be given one entry per person. To count as an entry, the entrant must be a member at Numerica, set up DreamUp in the Numerica Mobile App, and complete one savings transaction to a "dream". One random prize drawing will be held on January 6, 2026, after 9 a.m. PDT based on the entries received during the contest period. The winner does not have to be present for the drawing. There will be five grand prize winners.

The selected winners will each receive \$1,000 to the Numerica account of their choosing. The prize is not transferable. Winners are solely responsible for reporting and paying applicable state and federal taxes.

The winner will be notified by email or phone call on January 6, 2026. The winner will have 72 hours to claim their prize.
